My principal area of interest in city government is to ensure that individuals that serve our city as public employees act with the highest degree of ethics and dedication to serving our community and country. I have a Bachelor of Arts in Political Science from San Diego State University. I was employed as a social worker by the San Diego County Department of Social Services from 1994 to 1997. From 1997 to 2000, I was employed as a probation officer by the San Diego County Probation Department. From 2000 to until my retirement in 2020, I was employed as a probation officer by the US District Court in San Diego. In my capacity as a social worker and probation officer, I represented the Court in the performance of my duties. The Court required a high degree of integrity and dedication to duty and public service. I have extensive experience in writing reports for the Courts. My job as a probation officer required a high degree of understanding of federal, state, and local laws. My job as a probation officer required that I conduct an investigation into a defendant's personal history and characteristics, their role in the criminal act, and then provide the judge with an impartial and objective evidence-based assessment and recommendation as to the disposition in the matter (sentencing recommendation).
