RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
CHULA VISTA RECITING THE FACT OF THE GENERAL  
MUNICIPAL ELECTION HELD IN THIS CITY ON JUNE 7,  
2022, DECLARING THE RESULTS THEREOF, AND OTHER  
MATTERS AS ARE PROVIDED BY LAW

WHEREAS, a general municipal election was held and conducted in the City of Chula Vista, California, on Tuesday, June 7, 2022, as required by law, for the purpose of electing a Mayor, two members of the City Council to represent Districts 1 and 2, and a City Attorney, each for a full term, commencing in December 2022; and

WHEREAS, a notice of said election was duly and regularly given in the time, form, and manner as provided by law; and in all respects the election was held and conducted, and the votes cast at the election received and canvassed, and the returns made and declared, in the time, form, and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in charter cities; and

WHEREAS, pursuant to Resolution No. 2022-002 adopted on January 11, 2022, the election was consolidated with the statewide election, and the Registrar of Voters canvassed the returns of that election and has certified the results. The results are received and made a part hereof, attached as Exhibit 1.

NOW, THEREFORE, BE IT RESOLVED, DECLARED, DETERMINED, AND ORDERED by the City Council of the City of Chula Vista, that:

1. The City of Chula Vista had 163,847 registered voters eligible to vote in the June 7, 2022, election. There were 142 vote centers established in Chula Vista for the purpose of holding the election.
2. The total number of votes received by each candidate as follows:

5. That the City Clerk shall certify the passage and adoption of this resolution and enter it into the book of the original resolutions.
