






PROPOSED BOUNDARY OF



- HomeFed requests to form CFD via CMFA BOLD Program to finance public facilities and development impact fees
- Consistent with City's CFD Goals and Policies with certain exceptions
- CMFA oversees CFD district formation and administration, special tax formula, bond sale
- City retains approval of developer reimbursements and right to review of all CFD documentation



- Conduct noticed public hearing to allow bonds to be issued by CMFA
- Authorize the formation of Village 3, Phase II CFD through CMFA BOLD program and approve JCFA
- Approve form of Acquisition Financing Agreement
