I am co-owner of Tolteca Press, a local small press creating bilingual, bicultural books for children. Two books have been published thus far and the first book has won 6 book awards.

I am a retired educator, having served Southwestern College as a School Dean, Counselor and Instructor.



Through the attainment of higher education, one is able to move in circles of power and decision making, changing policies and laws that discriminate. One is also able to expose their children and community to the opportunities of higher education through example and through action.

# Education inspires hope

Education changes lives, opens minds, inspires creativity, and develops self-expression. Higher education brings hope for change, for personal growth, for personal wealth, and most importantly, personal empowerment of the individual, especially those coming from the most disenfranchised groups of our society.

# MANAGEMENT PHILOSOPHY

My management philosophy is based on the following basic truths from which form the basis of my life.

## LEADERSHIP PHILOSOPHY

My leadership philosophy can best be described as a unique blend of basic tenets that borrows from others and incorporates my personal values.

I incorporate some basic tenets of Servant Leadership, such as:

- a willingness to collaborate and entrust others with a common vision; and a desire to see connections rather than chasms.

It has been my desire to lead others as I would prefer to be led—with trust, enthusiasm, a listening ear, and a willingness to take action. At times, I have made difficult decisions and have advocated controversial stances on behalf of the students, the college, and my staff. I believe I have been true to my inner voice and that I have upheld the values and basic tenets as listed above. Each day brings a new challenge, a new opportunity to grow and learn.
