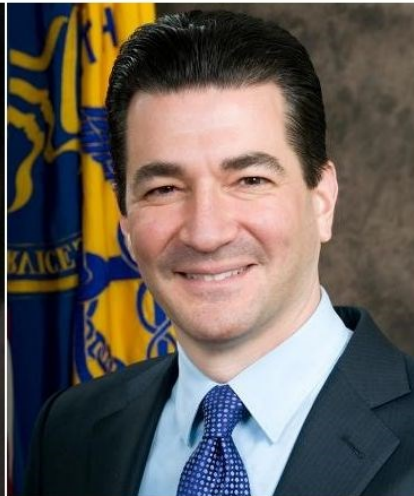

Proposed Fees Coming to San Diegans

Future Local Sales Tax Ballot Measure – half-cent measure (would require ballot measure)

Future MTS Sales Tax ballot measure – half-cent sales tax after 2024 presidential election (would require ballot measure) **PROPOSED MTS SALES TAX AND LIBRARY TAX NOV 2022 BALLOT**

Future State Mileage-Based Road User Fee - begin in 2026 that would \$0.023 per mile with a half cent increase on an annual basis (would require legislation)

Future Local Road User Charge - \$0.02 per mile starting in 2026 **MILEAGE TAX EXISTING ROADS
ALREADY PAID BY TAX PAYERS**

Future Ridehailing (UBER/LYFT) User Fee - \$1.25 for single trips; \$0.65 for pooled trips
