"March 2024, U.S. Soccer Foundation ("Foundation") approached the City of Chula Vista ("City") regarding the possibility of partnering to add a fenced soccer pitch with a resilient, acrylic surface ("Mini-Pitch") in the City of Chula Vista; and WHEREAS, City desires to add a Mini-Pitch to Harborside Park for the surroundingcommunity's use: and WHEREAS, pursuant to the terms of the proposed agreement, the Foundation will install one Mini-Pitch at Harborside Park; and WHEREAS, the Foundation will retain the right to place the Foundation's trademark, trade name or any design/logo owned or controlled by Foundation, and that of its funding partners, on the surface of the Mini Pitch; and WHEREAS, the Foundation will retain the right to use the Mini-Pitch for one day per year for five years for Special Events that are organized by *Foundation*; and WHEREAS, City will need to prepare a site at Harborside Park for installation of the Mini-Pitch; and WHEREAS, staff recommends an appropriation of \$160,000 to the fiscal year 2024-25 Capital Improvement Program PRK0344, "Harborside Park Renovations", from the available fund balance of Measure P for the costs associated with preparing the site for theinstallation of the Mini-Pitch; and WHEREAS, staff recommends amendment of the Measure P Infrastructure.
