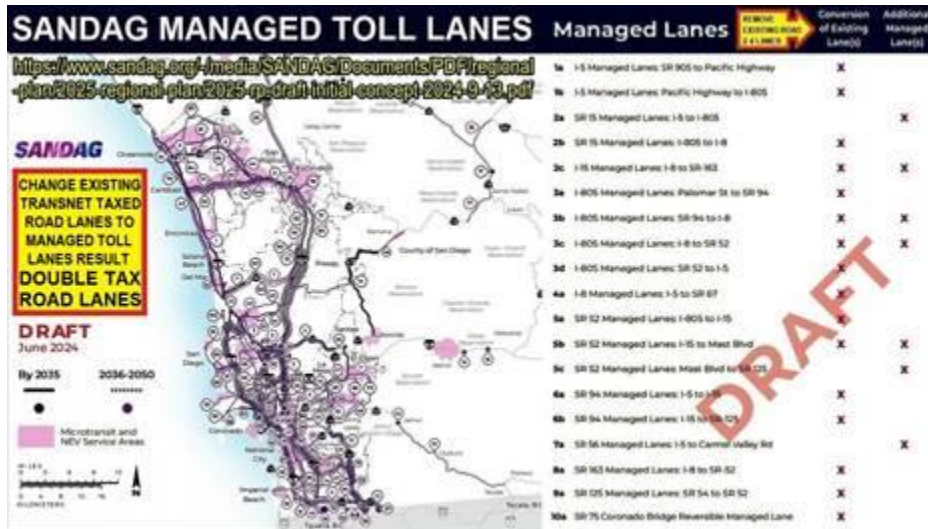

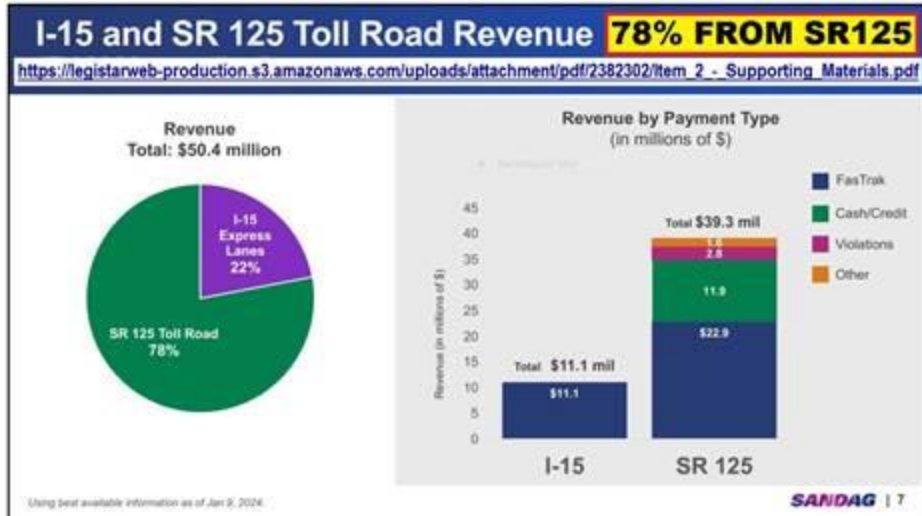

"Voters in 2004 approved a Tax extension of TransNet, a half-cent sales tax to fund freeway widenings, light rail expansion, habitat preservation, bike lanes and road improvements across the county. The tax went into effect four years later. So far, SANDAG has collected 25 percent less revenue under TransNet than it promised voters on the ballot."

The Project

The Interstate 805 (I-805) Managed Lanes, estimated to cost \$2.7 billion, will create a 27-mile Managed Lanes facility in the median of I-805 between State Route 905 (SR 905) and Interstate 5 (I-5).

Project Costs

The total cost for this project is estimated at \$2.7 billion (2006 dollars). This includes an estimated \$26.3 million for preliminary engineering studies and implementation of

The Need

I-805 is the backbone of mobility in the urban core of the San Diego region. It is a key north-south corridor that traverses the most heavily populated portion of the region. Average daily traffic on I-805 ranges from 110,000 to 250,000 vehicles with daily congestion lasting between two and four hours. Demand on this corridor is expected to exceed 330,000 vehicles in 2030 with congestion lasting over six hours.

Project Elements

- Four Managed Lanes
- Multiple access points between the Managed Lanes and general purpose lanes.
- Direct access ramps for buses and other high occupancy vehicles.
- Continuous Bus Rapid Transit (BRT) service will be operated on Managed Lanes (i.e. South Bay BRT).
- Solo drivers also will be able to pay a per trip fee to use the lanes. This Managed Lanes technique has been successfully used in the region, providing additional funds for transit service.

"The United States Supreme Court has made clear that a state charge violates the Commerce Clause "if it is facially discriminatory, has a discriminatory intent, or has the effect of **unduly burdening interstate commerce.**" *Amerada Hess Corporation v. Director, Div. of Taxation*, 490 U.S. 66, 75 (1989). It can be argued that many state tolling schemes fail every element of that analysis."

- "SANDAG staff reviewed approximately 90,000 customer accounts and found that 55,000 accounts had transactions that did not match between what the customers see on their account statements and what the internal accounting system document general ledger was showing. DECADES OF TRANSNET TAX 1988-2048 STOLEN DID NOT EXPAND FREEWAYS**

"Though existing Transnet Tax does not expire until 2048, SANDAG now expects local voters to approve three sales-tax increases within the next decade. The agency thinks it'll collect \$21.6 billion through countywide sales taxes approved by voters. Ride-hailing fees: SANDAG thinks it will start charging per-trip fees for companies like Uber and Lyft (\$1.25 for single riders, 65 cents for carpools), bringing in another \$1.3 billion. Funding will be used to Convert freeway lanes into Managed TOLL LANES between now and 2050. SANDAG expects to collect \$19.2 billion from the managed lane network – roughly the same amount of money it had anticipated coming from the road usage charge."
