The Board works with the City Attorney's Office, receives and initiates complaints of violations of the City's Code of Ethics; hears and investigates violations and transmits findings to the appropriate authority or City officer; renders advisory opinions or interpretations with respect to applications of the Code; proposes revisions to the Code to ensure its continuing pertinence and effectiveness.
